Dear Sirs:

I am writing concerning Closed Captioning requirements and an exemption from those requirements based on our Church being Economically Unable to afford the costs of closed captioning.

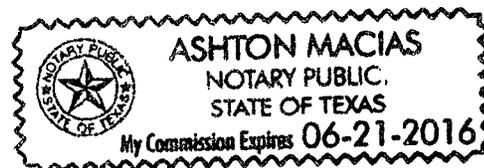
We have a program named, "The Bible Says" which is a 30 minute once per week program, Sunday morning at 10 AM Central. We have contacted the closed captioning business that the station KZBZ recommended to us, Amarillo Video Productions, which by the way, is the only one in Amarillo. They gave me a rate of \$200 per program without them doing the transcribing. The additional cost of transcribing would be at least \$100 per program. This would make our costs of the program to be \$1,200 to \$1,500 per month extra. As you can see from our attached financial statement, there is no way for us to be able to continue the program with these additional costs. We have sought extra funding for this endeavor but with very little response, in other words, if we don't come up with the funds, no one else will help on the cost.

Therefore, we believe that we should be granted an exemption from the closed captioning requirements based on the "Economically Burdensome Exemption from Closed Captioning Requirements".

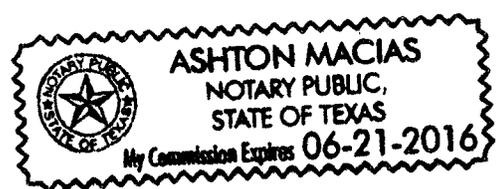
