

**SECOND AMENDMENT TO APPLICATION OF
HAMILTON RELAY, INC. FOR CERTIFICATION AS A
PROVIDER OF INTERNET RELAY SERVICES AND
INTERNET PROTOCOL CAPTIONED TELEPHONE
SERVICES**

Hamilton Relay, Inc. (“Hamilton”), by its counsel and pursuant to Section 1.65 of the Commission’s rules, hereby submits this second amendment to its December 5, 2011 application (the “Application”) for federal certification as a provider of Internet Relay services (“Internet Relay”) and Internet Protocol Captioned Telephone Services (“IP CTS”). By this amendment, Hamilton is providing updated information concerning various aspects of the Application, as follows.

I. Introduction

Due to changes in TRS service contracts over time, the second sentence of this section is changed to state: “Hamilton currently provides intrastate TRS and/or Captioned Telephone Services in 18 states and U.S. territories.”

II. Certification Information Required by the Second R & O

A. Forms of Internet-based TRS to Be Provided

In addition to the list of *IP CapTel Access Points* provided on page 3 of the original application, Hamilton now has two additional access points to reach IP CTS:

- CapTel 840i Model Telephone
- Alternatively, Hamilton CapTel customers with a voice plan and Wi-Fi connection can access Hamilton CapTel mobile applications without access to a 3G network.


CONCLUSION


