I am the superintendent of Mountain Pine School District. Due to the circumstances beyond my control, I was placed on Administrative Leave from March 7, 2012 until May 25, 2012. We had the process of closing the school year and preparing the school for maintenance to get the school open for the coming school year. I found out that the Edline contract had not been submitted as requested by USAC for the year 2012-2013 for Internet Access.

I typically am the person in charge of filing for USAC and in my absence my assistant Dr. Rebecca Morris normally would have taken over the responsibility. She had been undergoing cancer treatment and was unable to come to work on a daily basis during my leave.

We are a small school district of 600 students and this funding is critical in assisting us to maintain our budget. I know we should have completed this by June of 2012, but these circumstances were unforeseen and unavoidable.
