Wisely, Senior Project Coordinator for APCO's Comm Center & 9-1-1 Services, and the undersigned met with David Turetsky, Chief of the Public Safety & Homeland Security Bureau (PSHSB), members of the PSHSB staff (David Furth, Tim May, Aaron Garza, David Siehl, Nicole McGinnis, Dana Zelman by phone, and Erika Olsen by phone), and Henning Schulzrinne of the Office of Strategic Planning & Policy Analysis, to discuss issues related to indoor location accuracy for 9-1-1 calls. During the meeting Mr. Wisely discussed a recent report on the subject prepared by a CSRIC work group for which he served as co-chair. Mr. Wisely and the undersigned also recommended that the Commission initiate steps now to develop rules and policies to require a reasonable level of indoor accuracy for 9-1-1 calls.
