In response to your letter dated April 12, 2013, TVMax, Inc., d/b/a Wavevision ("TVMax") files herewith the following documents:

In addition, TVMax will provide, within 30 days of today's date, photocopies of additional documents reflecting the current financial status of TVMax and affiliated entities as requested in your letter.

TVMax appreciates the opportunity to provide information concerning its financial condition insofar as such information is relevant to determination of the forfeiture amount to be assessed against it, and is using its best efforts to provide all copies of documents requested, including providing redacted and unredacted photocopies of any documents that include confidential information. However, TVMax believes that the stated deadline for providing the information requested, namely, five business days from the date of your letter (*i.e.*, by April 19, 2013), is unreasonably short.

Therefore, to the extent that any responsive financial information provided by TVMax after the April 19, 2013 is not considered in the Commission's determination of the forfeiture amount, TVMax (and each of its affiliates) expressly reserve all available legal and equitable rights with regard to the amount of any forfeiture ultimately assessed.

TVMax requests that the unredacted copies of Federal Income Tax Returns and financial statements provided herewith be treated as confidential information and not be made available for public inspection pursuant to Section 0.459 of the Commission's rules.<sup>1</sup> Therefore, redacted versions of same are submitted together with the unredacted versions.

This request is based on the fact that the tax returns contain information within the scope of Section 0.457(d) of the Commission's rules,<sup>2</sup> including sensitive "commercial or financial information" concerning TVMax and its financial condition which "would customarily be guarded from competitors."<sup>3</sup>
