

IMPORTANT SERVICE-RELATED NOTICE FOR CONCENTRIC CUSTOMERS WITH CONSUMER DIAL SERVICE CORPORATE DIAL SERVICE WEB HOSTING SERVICE WITH DIAL OPTION ENABLED

Dear Valued Customer,

You are receiving this letter because you currently subscribe to Consumer Dial service, Corporate Dial service, or Web Hosting service with Dial option enabled ("Service" or "Services") from Concentric Cloud Solutions, LLC ("Concentric"). These Services are comprised of three components: (1) dial-up Internet connectivity; (2) e-mail; and (3) web hosting. The dial-up Internet connection component of your Service is provided by XO Communications Services, LLC ("XO"), an affiliate of Concentric. XO will be decommissioning the dial-up component of your Service on May 29, 2013. This notice impacts customers in Arizona, California, Idaho, Illinois, Kansas, Michigan, Minnesota, Missouri, New Hampshire, New Jersey, New York, Ohio, Oregon, Pennsylvania, Texas, Virginia, and Washington. The purpose of this notice is to make you aware of this change and your service options.

If you do not currently use the dial-up component of the Service to access the Internet, you may continue to use the remaining components of your Service, including your Concentric email address(es). However, if you currently use the dial-up component of the Service to access the Internet, you will need to find a new Internet access provider by May 29, 2013 to avoid any disruption to the email and web hosting components of your Service.

The Federal Communications Commission will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the Commission releases public notice of the proposed discontinuance. Address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, 445 12th Street, SW, Washington, DC 20554, and include in your comments a reference to the § 63.71 Application of XO Communications Services, LLC. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
