On behalf of Advanced Tel, LLC d/b/a EATEL ("Advanced Tel") John Staurulakis, Inc. respectfully submits this Amendment to the Advanced Tel Section 63.71 application to discontinue the provision of domestic long distance calling card and prepaid calling card services.¹ This Amendment clarifies the planned date of discontinuance and the method of customer notification.

The correct date of the planned Advanced Tel service discontinuance is on or after June 30, 2013 as indicated in the customer notices shown at Exhibit B of the Application, rather than the April 30, 2013 date stated in the Application.² Notices were sent to all customers by method of U.S. Mail on April 30, 2013.
