This letter serves as a request to review the USAC decision issued to deny funding for FRN 1735622. The Funding Commitment Adjustment Report stated: "It was determined that the applicant did not have a contract in place at the time of submission of the FCC Form 471. This determination was based on the contract which was signed on 6/25/2008 which is after the Certified Postmark Date of 2/6/2008."

Response: The applicant (Spartanburg County Public Libraries) is a government agency within the State of South Carolina; therefore, the applicant is allowed to participate in services provided through state contracts. Enclosed is a copy of the Statement of Award indicating that Spirit Telecom received the statewide contract for IP Telephony services on 3/20/2007 (before the Certified Postmark Date of 2/6/2008). Spirit Telecom was the service provider for the applicant (Spartanburg County Public Libraries) for Funding Year 2008. The State Contract meets our state and local procurement rules as a valid contract.

The enclosed Statement of Award document was provided to the reviewer during the PIA review and during the appeals process. However, this information was not mentioned by USAC in the Commitment Adjustment Report. We would like you to accept this documentation and reconsider USAC's decision to deny the funding request.
