## CHECK OR MONEY ORDER

When sending a payment through the mail, customers must include with the payment their first and last name, address, drivers license number and state, the ten-digit phone number where collect calls are to be received, and a six-digit Personal Identification Number or PIN they must create to access the account in the future. The PIN should be written down and kept in a secure location.

**All personal checks are verified through Telecheck before processing.**
