Dear Ms. Dortch:

Please accept the attached late-filed comments of the American Cable Association (“ACA”) in the above-referenced dockets in response to the Commission’s Notice of Proposed Rulemaking and Further Notice of Proposed Rulemaking.¹ ACA submitted comments in this proceeding on June 19, 2013,² but discovered in the early morning on June 20, 2013 that the incorrect file had inadvertently been uploaded. ACA subsequently requested that the Secretary’s office remove its earlier filing, which had not yet been made public, from its system. The attached comments are intended to replace ACA’s previous filing. The only substantive difference between the version of the comments uploaded previously and the attached version is the inclusion of an additional section that was completely drafted at the time the comments were initially submitted, but was inadvertently omitted from the final compilation of the uploaded file.

Acceptance of ACA’s comments, notwithstanding the short delay, will promote the development of a complete record and will not prejudice any interested party in the proceeding. Under the circumstances, and in the interest of a full and accurate record in this proceeding, ACA respectfully requests that the Commission accept its corrected comments as timely filed.
