Nudity, f-bombs, kinky sex, fetishes, orgies – on prime-time shows watched by millions of children. That's what is on the horizon, if the FCC's proposed rules change goes into effect. (For an example of the kind of thing the FCC **ALREADY** allows on TV, see **page 4**.)

But fortunately, the rules change hasn't gone into effect **YET!** The old rules **STILL APPLY!** And the law requires that, before such a change can go into effect, the FCC must allow the public to comment.

We cannot let this change go unchallenged!

You can **STILL** make your voice heard. The FCC is accepting public comments on the proposed rules change until June 20th.

PLEASE take this opportunity to let the FCC know that you **OPPOSE** their proposed changes – and remind them that they don't work for the entertainment industry's millionaire bosses, but for the American people!

File your public comment with the FCC, and tell them America's families want **MORE** enforcement of broadcast decency laws – **NOT LESS!**

The FCC will not accept general email comments. To be valid, you are required to file a formal

comment via the FCC's website, or U.S. mail.

Public Comment: FCC Proceeding 13-86

I oppose any changes to the current FCC indecency standards. The FCC must continue to vigorously oppose ALL indecent content, even if brief or "fleeting."

The Supreme Court has affirmed the FCC's authority to enforce policies prohibiting indecent broadcast content during hours when children are likely to be in the viewing or listening audience. Relaxing the current policy would not serve the public interest.

I urge the FCC to reject all proposals that would allow for the broadcast of expletives and nudity on FCC-licensed stations.
