**MOTION FOR EXTENSION OF TIME  
TO FILE COMMENTS IN RESPONSE TO  
TIME WARNER'S PETITION FOR PREEMPTION**

Pursuant to 47 C.F.R. § 1.46 of the Commission's rules, the North Carolina Rural Electrification Authority respectfully requests an extension of time for the filing of comments in the above-captioned proceeding, involving Time Warner's Petition for Preemption. The NCREA was served with Time Warner's Petition for Preemption by electronic mail on August 8, 2013 and received a copy of the Petition by regular mail on August 12, 2013. The date for filing comments is 15 days after the filing of the Petition. The NCREA respectfully requests an extension of time to file comments in this proceeding until September 6, 2013. In accordance with the requirements of 47 C.F.R. § 1.46(b), this extension request is being filed 7 days before the current filing deadline.

The NCREA asserts that the extension of time is for good cause, that it will not cause harm to any interested party, and that the public interest would be served by granting this extension of time.

**WHEREFORE**, for the foregoing reasons, the NCREA respectfully requests that the time for filing comments in response to Time Warner's Petition be extended to September 6, 2013.


