On August 29, 2013, Silver Star Telephone Company, Inc. (Silver Star) held a telephone conference with Julie Veach, Chief, Wireline Competition Bureau (WCB) and Steve Rosenberg, Rodger Woock, Suzanne Yelen, and Craig Stroup of the WCB, to discuss its pending Application for Review of the WCB's Order denying, in part, its request for waiver to correct data in the quantile regression analysis model. Ron McCue, President and Chief Operating Officer, Jeff England, Vice President and Chief Financial Officer, Rob Heiner, and Jeff Jensen participated in the meeting for Silver Star.

The purpose of the telephone conference was to discuss and attempt to arrive at a mutual understanding of the facts on land-based data for road and road-based crossings for Silver Star's Idaho and Wyoming study areas. Silver Star agreed to create a shape file that will reflect the publicly available data from Teton County, ID, Teton County, WY, Lincoln County, WY, Caribou County, ID, and Bonneville County, ID that Silver Star can model and share with the WCB staff for further review and discussion.
