AFFIDAVIT OF KEVIN MOTTUS

2. I am a very concerned citizen.

3. See attached additional studies which clearly provide evidence that there are biological effects due to exposure to Radio Frequency Radiation used and emitted by all wireless infrastructure, transmitters and the devices that access them.

4. The FCC should protect the public by warning them of these health effects and by developing actual safety standards rather than the guidelines we rely on now. These safety standards should be biologically based recognizing the existence of non-thermal effects and regulation, monitoring and enforcement of these safety standards should be carried out by the EPA which is qualified to do so since the FCC has been so ineffectual in the past.

5. For the FCC which is controlled and highly influenced by the wireless industry due to appointments to the FCC commission to continue to deny the existence of non-thermal effects and fail to warn and protect the public is criminal due to the disease, death and suffering this RF radiation exposure causes.

6. Attached are additional studies supporting the existence of non-thermal effects and mandating as recommended by the 2012 BioInitiative Report a lowering of acceptable exposure levels to .0001uW/cm². This recommended exposure level also reinforces the need for wired connections to the internet and phone communications when and wherever possible to minimize our population's RF radiation exposure which is in sharp contrast to the FCC's current drive to maximize wireless coverage, use and therefore maximize our population's RF radiation exposure and the associated health effects (cancer, cardiac and immune system dysfunction as well as behavioral and developmental problems in children). Wireless should be made illegal due to its health effects on our population; instead, wired connections to the internet and wired connections for phone communications should be used and proliferated. Wireless connections are not a necessity; they are a convenience which is not justified when considering the broad health impact to our population and individual suffering due to the disease and death the microwaves used by wireless is causing.
