The Baraga Telephone Company's demonstration of complying with applicable service quality standards and consumer protection rules:

In establishing this certification in its *2005 ETC Order*,¹ the FCC found that an ETC must make "a specific commitment to objective measures to protect consumers."² The Commission found that for wireless ETCs, compliance with CTIA's Consumer Code for Wireless Service would satisfy this requirement" and that the sufficiency of other commitments would be considered on a case-by-case basis.³ In this context, the FCC stated, "to the extent a wireline or wireless ETC applicant is subject to consumer protection obligations under state law, compliance with such laws may meet our requirement."⁴

The Baraga Telephone Company ("Company") hereby certifies that it is complying with applicable service quality standards and consumer protection rules. The Company is subject to consumer protection obligations under state law. These obligations include, but are not limited to, the following: (1) filing a Local Exchange Tariff pursuant to the requirements of The Michigan Public Service Commission (MPSC), as specified in Section 202(b) of the Michigan Telecommunications Act (MTA) and MPSC Case No. U-11103, which disclose rates, terms and conditions of service to customers; (2) adherence to Michigan state consumer protection requirements governing

telephone providers, Prohibitions as identified in Sections 305 and 502 of the MTA, Costing Procedures as determined by the MPSC in Case No. U-11103, and Compliance with Anti-Slamming Procedures as adopted in MPSC Case No. U-11757 and Case No. 11900; and (3) CPNI, Red Flag Rules and other applicable federal and state requirements governing the protection of customers' privacy.

The Baraga Telephone Company's demonstration of ability to function in emergency situations:

The Baraga Telephone Company ("Company") hereby certifies that it is able to function in emergency situations as set forth in the Code of Federal Regulations, Title 47, Part 54, Subpart C, §54.202(a)(2)¹ and the Michigan Telecommunications Act (MTA). The Company's network is designed to remain functional in emergency situations without an external power source, is able to reroute traffic around damaged facilities, and is capable of managing traffic spikes resulting from emergency situations as required by Section 54.202(a)(2). The Company can change call routing translations as needed to reroute traffic around damaged facilities. Changing call routing translations will also allow the Company to manage traffic spikes throughout its network, as emergency situations require.

Specifically, each central office building is supplied with standby generators and battery back-up that enable the central office to keep running until power is restored so long as fuel is available, or until system changes are made to reroute traffic. The Company has battery backup at all office locations and in its electronic equipment sites in accordance with the specifications identified in Section 305c(a) of the MTA, 484.2305c Emergency power requirements; compliance.

¹ Section 54.202(a)(2) requires ETCs that are designated by the Commission to "demonstrate its ability to remain functional in emergency situations, including a demonstration that it has a reasonable amount of back-up power to ensure functionality without an external power source, is able to reroute traffic around damaged facilities, and is capable of managing traffic spikes resulting from emergency situations."

The Baraga Telephone Company, BTC, serves the Keweenaw Bay Indian Community, KBIC, reservation located in Baraga County, Michigan. It should also be noted that I am a member of this tribal community, (enrollment number 5179). Our primary customer service representative in the Baraga office is also a tribal member.

Throughout the year 2012 we at BTC have worked on a couple of projects with the KBIC. We communicated primarily with Mr. Ken Marshall and we also met with the Tribal President, Mr. Warren C. Swartz, Jr. In previous years BTC has worked with Tribal attorneys to try to resolve sales tax issues between the Tribe and the State of Michigan.

At the end of 2012 all of the Tribal Anchor Institutions were connected by fiber to the Baraga central office and also to an intra-tribal high speed data, fiber optic network installed and maintained by BTC.


During the year 2012 we discussed Tribal needs and deployment planning with service to Tribal Community anchor institutions with Mr. Marshall. We also discussed Rights of Way compliance, Land Use permitting, Facilities siting, Environmental Review processes and compliance with Cultural Preservation processes with Mr. Marshall.

Representatives of the Baraga Telephone Company met with the Tribal President Swartz on Oct. 17, 2012 to discuss any problems that the Tribe might have with BTC and how we might better serve the Keweenaw Bay Indian Community. This discussion included feasibility and sustainability planning and marketing in a culturally sensitive manner.


