

On November 21, 2013, representatives of NextNav, LLC (“NextNav”), participated in two meetings with Commission officials to discuss the significant progress that has been made in the development of indoor location technologies to support wireless calls to E911 emergency first responders. One of the meetings was held with Commissioner Mignon Clyburn and her Legal Advisor, Louis Peraertz. The other meeting was held with Daniel Alvarez, Legal Advisor for Chairman Tom Wheeler. Participating in the meetings on behalf of NextNav were Gary Parsons, CEO of NextNav; Bruce Cox, Senior Director, Regulatory & Public Safety for NextNav; and the undersigned. Rajendra Singh, Chairman of the Board for NextNav, also participated in the meeting with Commissioner Clyburn.

The substance of the meetings was substantially identical to previous *ex parte* meetings involving NextNav and Commission officials, the substance of which were detailed in an *ex parte* filing submitted by NextNav in this docket on November 13, 2013 and in comments filed by NextNav in this docket on September 25, 2013.


