The Mississippi Department of Corrections, the South Dakota Department of Corrections, the Strafford County Department of Corrections in New Hampshire, the Berks County Jail System in Pennsylvania, the Chester County Prison in Pennsylvania, the City of Chesapeake Sheriff's Office in Virginia, the Newberry County Sheriff's Office in South Carolina, the Mobile County Sheriff's Office in Alabama, and the Montgomery County Correctional Facility in Pennsylvania (collectively, the "Correctional Institutions") respectfully submit this letter in support of the Motion for Extension of Time to File Comments and Reply Comments submitted by the Ohio Department of Rehabilitation and Correction ("ODRC") in the above-referenced docket on December 6, 2013.

Each of the Correctional Institutions is charged with implementing rules and procedures that govern inmate access to telephone services, and oversee the inmate calling services offered at the correctional facilities within their jurisdiction. Each of the Correctional Institutions has an interest in the proposals set forth in the Commission's Further Notice of Proposed Rulemaking. The additional time requested by the ODRC will provide the Correctional Institutions with adequate time to fully evaluate the Commission's proposals and provide a more complete factual and legal record in this proceeding.
