On Wednesday, December 18, 2013, Alan Carr of the LightSquared Special Committee, Chris Rogers of the LightSquared Special Committee, Neal Goldman of the LightSquared Special Committee, Paul Basta of Kirkland and Ellis LLP, counsel to the LightSquared Special Committee, Bryce Fraser, Managing Director, Fortress Investment Group, Patrick Daniello, Managing Director, JP Morgan, Doug Smith, Chairman of the Board and Chief Executive Officer of LightSquared, Matthew Barr of Milbank, bankruptcy counsel to LightSquared, and Reed Hundt, representative of LightSquared, met with Ruth Milkman, Chief of Staff to Federal Communications Commission (“FCC”) Chairman Thomas Wheeler, and Jonathan Chambers, Chief of the FCC’s Office of Strategic Planning and Policy Analysis.

On Thursday, December 19, 2013, Alan Carr of the LightSquared Special Committee, Chris Rogers of the LightSquared Special Committee, Paul Basta of Kirkland and Ellis LLP, counsel to the LightSquared Special Committee, Dean Dakolias, co-Chief Investment Officer and Jack Neumark, Vice President, Fortress Investment Group, Patrick Daniello, Managing Director, JP Morgan, Peter Reed, Managing Director, MAST Capital, Doug Smith, Chairman of the Board and Chief Executive Officer of LightSquared, Matthew Barr of Milbank, bankruptcy counsel to LightSquared, and Reed Hundt, representative of LightSquared, met with Ms. Milkman, Mr. Chambers and FCC Chairman Thomas Wheeler.

In these meetings, the private sector meeting attendees provided a status update on LightSquared’s bankruptcy cases, outlined a proposed restructuring, discussed the relationship of those cases and their schedule to ongoing LightSquared proceedings before the Commission, and urged that the above-referenced modification applications be granted in a timely manner.
