**RE: Errata to Washington Certification of Support for High-Cost Eligible  
Telecommunications Carrier Pursuant to 47 C.F.R Sections 54.314, WC Docket No.  
10-90**

To the Filing Representatives:

On October 30, 2013, the Washington Utilities and Transportation Commission (WUTC) filed a letter in the above-referenced docket certifying that all federal high-cost support provided to Eligible Telecommunications Carriers (ETCs) in Washington was used in the preceding calendar year, and will be used in the coming calendar year, only for the provision, maintenance, and upgrading of facilities and services for which the support is intended, consistent with 47 U.S.C. § 254(e). The WUTC has discovered two errors in that certification regarding T-Mobile West LLC. The certification should be corrected to reflect: (1) the company changed its name from T-Mobile West Corporation to T-Mobile West LLC in 2012; (2) the company acquired three additional Study Area Codes (SACs), 528001, 528002 and 528003 in the Mobility Fund Phase I auction in 2012.
