Pursuant to the requirements of 47 C.F.R. § 53.314, the Louisiana Public Service Commission hereby certifies to the Federal Communications Commission and the Universal Service Administrative Company that the telecommunications carrier included in this letter, Northeast Louisiana Telephone Company, inc. is eligible to receive federal high-cost support for the program years cited.
