**CONTINUING INTEREST EXPRESSION**

The Hualapai Tribe, ("Tribe), a Native American entity, hereby files this Expression of Continuing Interest in accordance with the Threshold Qualification Window for Peach Springs, Arizona opening announced November 27, 2013. The Tribe filed the original Petition for Rulemaking which resulted in the allotment of FM Channel 265A to the community of Peach Springs, Arizona and, in accordance with the Threshold Qualification Window requirements, the Tribe is filing its expression of continuing interest in FM Channel 265A at Peach Springs, Arizona. By reference, the Tribe incorporates all of its prior filings in MB Docket 12-374

As noted in the Threshold Qualifications Window announcement, the Tribe meets all of the requirements for the allotment of a new FM facility to a community that qualifies as a Tribal Allotment. In accordance with the required expression of continuing interest, the Tribe specifically requests that the Commission process its pending Application for Construction Permit, (FCC File No. BNPH-20121010AAO). If awarded the Construction Permit, the Tribe will construct and operate the requested facility at Peach Springs, Arizona.

A grant of the requested Construction Permit to the Tribe will allow the Tribe to provide programming to the community of Peach Springs, Arizona that will serve the

needs of the Hualapai Tribe. The Tribe intends to use the FM facility to provide programming to the community that will support the unique cultural, social and economic needs of the Tribe.

In view of the foregoing, the Tribe requests that the Commission process the outstanding application for a new FM facility filed by the Hualapai Tribe on November 10, 2012. The new FM facility will serve the public interest and allow the Tribe to operate an aural facility providing service to its Tribal members residing in the service area of the facility.
