NOTICE OF LIMITED, SPECIAL APPEARANCE

The undersigned attorneys, Danny E. Ruhl and Timothy J. Anzenberger, of the law firm of Copeland, Cook, Taylor & Bush, P.A. ("Copeland Cook"), hereby submit this *Notice of Limited, Special Appearance* (the "Limited Appearance"), in connection with paragraphs 6 and 20 of the *Memorandum Opinion and Order* (FCC 13M-22) (the "Order") issued in the above-captioned proceeding (the "FCC Proceeding") on or about December 19, 2013, by the Honorable Richard L. Sippel, Chief Administrative Law Judge.

1. On August 1, 2011, Maritime Communications/Land Mobile, LLC filed a bankruptcy proceeding, styled *In re Maritime Communications/Land Mobile, LLC*, Case No. 11-13463-DWH, in the United States Bankruptcy Court for the Northern District of Mississippi (the “Bankruptcy Proceeding”). Copeland Cook has been representing Warren C. Havens (“Havens”), as well as Skybridge Spectrum Foundation, Verde Systems LLC, Environmental LLC, Intelligent Transportation & Monitoring LLC, and Telesaurus Holdings GB LLC (collectively, “SkyTel”), in the Bankruptcy Proceeding.

2. Copeland Cook has also, from time to time, and as requested by Havens and agreed to by Copeland Cook, provided advice, input, and/or assistance to Havens regarding, primarily, certain bankruptcy issues or implications related to and/or arising in connection with the FCC Proceeding.

3. The Order requests, among other things, “the date that [‘assisting counsel’] was retained or otherwise began assisting Mr. Havens in [the FCC Proceeding].” The following information is provided in response to that request.

4. On or about November 10, 2013, Havens requested the undersigned attorneys to provide certain discrete, limited advice/input, primarily regarding bankruptcy related issues and/or questions, which advice/input was ultimately used in connection with the *Havens-SkyTel First Motion Under Order 13M-19 to Reject Settlement, Proceed with the Hearing and Provide Additional Relevant Discovery*, which motion was filed by Havens in the FCC Proceeding on or about December 2, 2013 (the “December 2 Motion”). The undersigned attorneys provided or endeavored to provide the requested discrete and limited advice/input.

5. On or about December 4, 2013, Havens requested the undersigned attorneys to provide certain discrete, limited assistance, primarily regarding bankruptcy related issues, in

connection with the *Havens Opposition to Joint Motion of Enforcement Bureau & Maritime for Summary Decision on Issue G*, which opposition was filed by Havens in the FCC Proceeding on or about December 16, 2013 (the "December 16 Motion"). The undersigned attorneys provided or endeavored to provide the requested discrete and limited assistance.

6. Havens and Copeland Cook (including through the undersigned attorneys) have agreed, after consultation and upon informed consent: (a) that the advice, input, and/or assistance given by Copeland Cook in connection with the FCC Proceeding is limited in scope and objective; (b) that Havens has not retained or authorized Copeland Cook (including the undersigned attorneys) to serve as Havens' and/or SkyTel's general, "representative counsel" in the FCC Proceeding; and (c) that neither Copeland Cook nor the undersigned attorneys are at this time appearing in the FCC Proceeding in that capacity, based on the Limited Appearance or otherwise. Rather, Havens continues herein *pro se*.

7. The undersigned attorneys are admitted to the practice of law in the State of Mississippi.


