NOTICE OF LIMITED OR SPECIAL APPEARANCE

The undersigned attorney, James Ming Chen, hereby submits this *Notice of Limited or Special Appearance* [hereinafter Limited Appearance], in connection with paragraphs 6 and 20 of the *Memorandum Opinion and Order* (FCC 13M-22) [hereinafter Order 13M-22] issued in the above-captioned proceeding [hereinafter EB Docket No. 11-71] on or about December 19, 2013, by the Honorable Richard L. Sippel, Chief Administrative Law Judge.

1. I have provided assistance to Mr. Warren Havens in connection with EB Docket No. 11-71. Order 13M-22 requests “the date that [‘assisting counsel’] was retained or otherwise began assisting Mr. Havens in this proceeding, as well as the jurisdiction(s) of bar admission.” In response to that request, I provide the following information.

2. I was retained by Mr. Havens on October 13, 2012, in connection with *Havens v. Mobex Network Services, LLC*, Civ. Action No. 11-993 (filed D.N.J. Feb. 18, 2011), and related cases. Under that agreement, I entered a notice of appearance on November 29, 2012, in this proceeding on behalf of Mr. Havens (as an individual), Environmental LLC, Intelligent Transportation and Monitoring Wireless LLC, Verde Systems LLC, Skybridge Spectrum Foundation, Telesaurus Holdings GB LLC, and V2G LLC. That notice of appearance was not intended “as a waiver or modification by Mr. Havens of arguments he has made and actions taken *pro se*, or the right ... to further *pro se* participation.”

3. On February 14, 2013, Mr. Havens filed notice of my discharge as counsel in this proceeding due to objections that Maritime Communications/Land Mobile had raised with respect to my role in the *Havens v. Mobex Network Services* case before the United States District Court for the District of New Jersey. On February 20, 2013, I submitted a request that Chief Judge Sippel accept that discharge. In Order FCC 13M-8, issued on or about May 1, 2013, Chief Judge Sippel accepted my request.


4. On July 1, 2013, I became of counsel to Technology Law Group, L.L.C., of Washington, D.C. Prior to my affiliation with Technology Law Group, Mr. Havens had engaged that firm’s services in connection with various matters. After July 1, 2013, I provided assistance to Mr. Havens in this proceeding under his agreement retaining the services of Technology Law

Group. Technology Law Group ceased providing advice in Docket 11-71, as well as legal services in all other matters, to Mr. Havens and the LLCs in mid-November 2013.

5. On November 24, 2013, Mr. Havens, after consultation and upon informed consent, engaged me to provide assistance to him in EB Docket No. 11-71. Mr. Havens and I agreed (a) that any assistance given by me in connection with this proceeding is limited in scope and objective; (b) that I have not been retained or authorized to serve as general, “representative counsel” to Mr. Havens or to any of the companies associated with him; and (c) that I am not appearing in a general, representative capacity in this proceeding, based on this Limited Appearance or otherwise. Rather, Mr. Havens continues to proceed *pro se*.

6. I am admitted to the practice of law in the Commonwealth of Virginia and in the District of Columbia.


