Dear Ms. Dortch:

On September 24, 2013, Frontier Communications Corp. filed its annual report and certifications as required by sections 54.313 and 54.422 of the Commission's rules in accordance with the guidance of the Public Notice issued August 6, 2013, for the companies listed below.¹ Following consultation with USAC, Frontier hereby refiles a revised version of Form 481 for those companies. Today's filing restates the number of complaints for SACs 170149 and 170152 due to an errant computation of the complaint rate in the previous totals. All reports have also been revised to add a reference to Pennsylvania state consumer protection rules. A copy of this report is also being filed with the Universal Service Administrative Company and the relevant State public service commission.

Portions of this filing for select companies are being made confidentially in accordance with the Federal Communications Commission's ("Commission") *Third Protective Order* in this docket². Specifically, Frontier requests confidential treatment of the detailed reporting of outages lasting longer than 30 minutes in 2012, which includes the location, cause, duration and efforts taken to prevent further outages. This information is competitively sensitive and is not normally released to the public; release of such sensitive data could give Frontier's competitors an advantage in the
