



Customer Proprietary Network Information Certification Attachment A

NuWave Holdings, Inc. has established practices and procedures adequate to ensure compliance with Section 222 of the Communications Act of 1934, as amended, ("Section 222") and the Federal Communications Commission's ("FCC") rules pertaining to customer proprietary network information ("CPNI") set forth in sections 64.2001 – 64.2011 of the Commission's rules. This attachment summarizes those practices and procedures, which have been updated so that they are adequate to ensure compliance with the Commission's CPNI rules.

NuWave Holdings, Inc. provides private telecommunications services over dedicated lines to large enterprise and carrier customers pursuant to ICB contracts. NuWave Holdings, Inc.'s customer contracts uniformly contain confidentiality agreements that address customers' private information. It is NuWave Holdings, Inc.'s policy not to disclose CPNI except as specifically set out in its contracts with its customers and where required by law.

Safeguarding against pretexting

- NuWave Holdings, Inc. takes reasonable measures to discover and protect against attempts to gain unauthorized access to CPNI, including the authentication of customers prior to disclosing CPNI based on customer-initiated contacts. NuWave Holdings, Inc. is committed to notify the FCC of any novel or new methods of pretexting it discovers and of any actions it takes against pretexters and data brokers.

Training and discipline

- NuWave Holdings, Inc. has an express disciplinary process in place for violation of the NuWave Holdings, Inc.'s CPNI practices and procedures. NuWave Holdings, Inc. employees are required to review and abide by NuWave Holdings, Inc.'s Code of Conduct, which, prohibits all employees from using customer information other than for providing service to the customer or as required to be disclosed by law.

NuWave Holdings, Inc.'s use of CPNI

- NuWave Holdings, Inc. uses CPNI for the following purposes:
 - (1) To initiate, render, maintain, repair, bill and collect for services;
 - (2) To protect its property rights; or to protect its subscribers or other carriers from fraudulent, abusive, or the unlawful use of, or subscription to, such services;
 - (3) For network maintenance; and
 - (4) As required by law.

- NuWave Holdings, Inc. does not distribute CPNI to third parties for their sales or marketing purposes. Nor does NuWave Holdings, Inc. share, sell, lease or otherwise provide CPNI to any of its affiliates, suppliers, vendors, or any other third party for the purpose of marketing any service.
- NuWave Holdings, Inc. does not share, sell, lease or otherwise provide CPNI to any third party except pursuant to appropriate non-disclosure agreements. NuWave Holdings, Inc. will not otherwise disclose CPNI to a third party except when required by a lawfully issued government subpoena.

Additional safeguards

- NuWave Holdings, Inc. does not use CPNI for marketing purposes and therefore does not have records to maintain regarding marketing campaigns that use its customers' CPNI.
- NuWave Holdings, Inc. has established a supervisory review process designed to ensure compliance with the FCC's CPNI rules.
- NuWave Holdings, Inc. designates one or more officers, as an agent or agents of the NuWave Holdings, Inc., to sign and file a CPNI compliance certificate on an annual basis. The certificate conforms to the requirements set forth in FCC rule 64.2009(e).
- NuWave Holdings, Inc. does not disclose CPNI over the phone and does not allow for online access to CPNI.
- In the event of a breach of CPNI, NuWave Holdings, Inc. will comply with all applicable breach notification laws.
