Take Action Against FCC's New "Anything Goes" Rule Change!

Nudity, f-bombs, kinky sex, fetishes, orgies – on prime-time shows watched by millions of children. That's what is on the horizon, if the FCC's proposed rules change goes into effect. (For an example of the kind of thing the FCC **ALREADY** allows on TV, see **page 4.**)

But fortunately, the rules change hasn't gone into effect **YET!** The old rules **STILL APPLY!** And the law requires that, before such a change can go into effect, the FCC must allow the public to comment.

We cannot let this change go unchallenged!

You can **STILL** make your voice heard. The FCC is accepting public comments on the proposed rules change until June 20th.

PLEASE take this opportunity to let the FCC know that you **OPPOSE** their proposed changes – and remind them that they don't work for the entertainment industry's millionaire bosses, but for the **American people!**

File your public comment with the FCC, and tell them America's families want **MORE** enforcement of broadcast decency laws – **NOT LESS!**

The FCC will not accept general email comments. To be valid, you are required to file a formal

comment via the FCC's website, or U.S. mail.

Please follow these instructions, to ensure your comment is accepted by the FCC:

BY COMPUTER:

Public Comment: FCC Proceeding 13-86

I oppose any changes to the current FCC indecency standards. The FCC must continue to vigorously oppose ALL indecent content, even if brief or "fleeting."

Due to the fact that the program is a cartoon and airs in prime time, millions of children are exposed to this perverted show. ■ An elderly man is shown naked but for panties, bound spread-eagled to a large wooden "X." A masked dominatrix stands beside him. Lewis spins the "X" in like a wheel of fortune. Roger swings by on a trapeze. A naked man,

wearing only underwear, hangs upside-down from the ceiling.

■ Stan ties a noose around his neck and holds it up, as if to strangle himself.

■ Stan swings on the trapeze, wearing a bondage outfit and garters. Below, as part of the orgy, are seen clowns, nurses, dominatrices, and various farm animals. Roger wears a Nazi SS uniform.
