I, Mark Woelfel, certify that I am an officer of Coral Wireless, LLC (“Coral”), and acting as an agent of Coral, that I have personal knowledge that Coral has established operating procedures that are adequate to ensure compliance with the Commission’s CPNI rules. *See* 47 C.F.R. § 64.2001 *et seq.*

Attached to this certification is an accompanying statement explaining how the procedures of Coral ensure that Coral is in compliance with the requirements (including those mandating the adoption of CPNI procedures, training, recordkeeping, and supervisory review) set forth in section 64.2001 *et seq.* of the Commission’s rules.

Coral has not taken any actions (proceedings instituted or petitions filed by a company at either state commissions, the court system, or at the Commission against data brokers) against data brokers in the past year.

Coral has not received any customer complaints in the past year concerning the unauthorized release of CPNI.

The company represents and warrants that the above certification is consistent with 47 C.F.R. § 1.17 which requires truthful and accurate statements to the Commission. The company also acknowledges that false statements and misrepresentations to the Commission are punishable under Title 18 of the U.S. Code and may subject it to enforcement action.

### Statement

Coral is a provider of Commercial Mobile Radio Service (“CMRS”) and does not offer telecommunications services to its customers in categories other than CMRS. Coral does not currently use customer proprietary network information (“CPNI”) for the purpose of marketing services other than CMRS, customer premises equipment, information services, and adjunct-to-basic services (collectively, “CMRS-Related Services”) to its customers.

Coral does not share CPNI with affiliates or with any other third parties, except for the purpose of marketing CMRS-Related Services. The provision of CPNI for the purpose of marketing CMRS-Related Services takes place under strict non-disclosure agreements and is accomplished in a tightly controlled information technology environment. Other than for the purposes described above, Coral does not share CPNI with affiliates or with any other third parties, other than pursuant to requests by duly-authorized law enforcement officials. Consequently, Coral is not required to maintain either an “opt-in” or “opt-out” system with respect to CPNI, although Coral has voluntarily implemented a process by which customers may opt out of marketing messages. In the event that Coral were to change the ways in which it uses CPNI, any such change would be reviewed and approved by the company’s CFO, who is familiar with the FCC’s rules governing the use of CPNI and who is the certifying officer for CPNI purposes.

Coral has established procedures to maintain the security of CPNI of its customers. For example, Coral requires that each customer supply a phone number and unique security code before accessing any information concerning his or her account. Further, while Coral retains call detail records and stores data in a central location for the sole purpose of responding to valid law enforcement requests, these records are under no circumstances made available to Coral’s customers.
