Healing Miracles is a non profit Christian television program that airs twice every week (8 times a month) on TBN's Church Channel in America and across the world. It is designed for prayer, teaching and preaching about the Salvation and the healing power of Jesus. The program is meant to administer divine healing to people with various forms of addictions, sickness and diseases (both physical and spiritual) that doctors have given up on with no hope for their survival.

2) The Nature and cost of closed captions for Healing Miracles TV program

The process to provide closed captioning for our television program *Healing Miracles* is as follows: The tape (each tape includes one episode of *Healing Miracles*) is edited by Picnic Table Productions and is then mailed to multiple companies in order to complete the closed captioning process. We mail our edited shows to different companies because Picnic Table Productions does not provide closed captioning. This process includes transcription and laying the final product to tape which is a major expense. Each time the program is mailed to individual companies for the completion of their portion of this process, an additional expense is incurred for the ministry. This has been highlighted on the invoices included in this package for the payments made since we start our broadcast last year.

Sometimes we miss the deadlines to submit new episodes for airing due to the long process of mailing shows from one State to another for the closed captions to be done. At some point we had to cancel some of our programs due to the long process and financial burden.

The cost associated with closed captioning for Healing Miracles

The cost associated with closed captioning for our TV program "*Healing Miracles*" averages between \$2,472-\$4,400 a month (\$29,644-\$52,800 annually) depending on whether the program is in SD (Standard Definition) or HD (High Definition) format. This is based on producing 4 different shows a month that are aired twice each week totaling 8 episodes. The Closed Captioning process for each tape is explained in the attached letter from our production company Picnic Table Productions.

Documentation

Enclosed are invoices from picnic table productions explaining all costs associated with the closed captioning process. All expenses have been highlighted.

3) The impact of closed captioning on Healing Miracle show.

Freedom House Church International is a very small congregation that was established in August of 2012 with a vision to minister healing and Salvation to people through television.

Financial support for our ministry comes from the tithes and offerings of our small congregation. The costs associated with closed captioning are extremely burdensome on our young ministry. The result of having to continue to pay these fees would leave us with no choice but to discontinue our television ministry that is a huge blessing to many people across America since we started last October, 2013.

4) Financial information:

Enclosed is a chart of income and expenditure for the ministry from August 2012-December 2013.

Our distributor (The Church Channel) initially made it clear that they do not provide closed captioning to their clients and they cannot exempt clients from closed captioning unless they receive an exemption letter from the FCC.

IRS Form 990-N

Enclosed is approved IRS documentation for our ministry. Our ministry is very small at this point and we are only required to file ePostcard (Form 990-N) by the IRS for small organizations.

Assets

We are still very small and we do not have any assets at this time. Therefore we do not have most of the information requested at this point in our ministry.


