Dear Ms. Dortch:

This is to inform you that on May 23, 2014, on behalf of Harbinger Capital Partners (“Harbinger”), the undersigned and David Thompson, both of the law firm of Cooper & Kirk PLLC, met with Jennifer Tatel, Jonathan Chambers, Charles Mathias and Hillary Burchuk, all of the FCC staff, and, by telephone, with Nicholas Bovan and Alicia Simmons of the United States Department of Justice (“DOJ”). The undersigned advised the FCC and DOJ officials of the following:

In reliance on its March 2010 agreement with the FCC, Harbinger expended billions of dollars to acquire LightSquared and finance an agreed-upon plan for a broadband wireless network that satisfied the terms established by the FCC. However, in 2011, the FCC ordered an indefinite halt to further development of that network on the basis of potential GPS interference problems. These problems were not of Harbinger’s making. Rather, as the FCC acknowledges, they were the result of the GPS industry’s improper use of the L-band spectrum. Moreover, by taking this action, the federal government has effectively reallocated the L-band spectrum to the GPS industry, contrary to its obligations to Harbinger under their agreement. Despite this conduct, considerable efforts were made to propose alternative strategies that would mitigate the situation. Unfortunately, these efforts still have not borne fruit.


The undersigned urged the FCC to mitigate further damage to Harbinger by taking immediate, positive action in this matter.
