During the meeting, the participants discussed the plans of Chanute, Kansas and Northeast Oklahoma Electric Cooperative (through its subsidiary Bolt Fiber Optic Services) to provide reliable, robust, and affordable broadband services to their customers in rural parts of Kansas and Oklahoma. The participants provided the attached documents during the course of the meeting, and these documents describe in detail how these utilities are providing benefits to the community for broadband, as well as advanced metering for their electric, gas and water utility customers. Chanute has also filed an expression of interest in the Commission's rural broadband experiments proceeding (WC Docket No. 10-90, filed Mar. 5, 2014).

As UTC has explained throughout this proceeding in comments and various meetings, utilities like Chanute and Northeast Oklahoma Electric Cooperative are uniquely qualified and committed to promote broadband access in unserved areas of rural America. Their business model is predicated upon serving the community, which is manifested by extended returns on investment and the deployment of ultra-high speed, reliable and future-proof fiber to the home networks. Utilities filed over 200 expressions of interest in the rural broadband experiments proceeding, which demonstrates their significant and widespread interest in providing reliable, robust and affordable broadband throughout rural America.
