**WIRELINE COMPETITION BUREAU WILL TREAT AS TIMELY FILED ANY COMMENTS  
FILED IN RESPONSE TO THE OPEN INTERNET NOTICE OF PROPOSED RULEMAKING  
AND THE FRAMEWORK FOR BROADBAND INTERNET ACCESS SERVICE REFRESHING  
THE RECORD PUBLIC NOTICE IF FILED BY JULY 18, 2014**

**GN Docket Nos. 10-127, 14-28**

By this Public Notice, the Commission's Wireline Competition Bureau (Bureau) announces that it will treat comments filed in response to the *Protecting and Promoting the Open Internet Notice of Proposed Rulemaking* and the *Framework for Broadband Internet Access Service Refreshing the Record Public Notice* as timely if filed by midnight, July 18, 2014. On May 15, 2014, the Commission released the *Notice of Proposed Rulemaking*.<sup>1</sup> The *Notice of Proposed Rulemaking* set dates for comments and reply comments as July 15 and September 10, 2014, respectively.<sup>2</sup> On May 30, 2014, the Commission released a Public Notice seeking to refresh the record in the 2010 *Framework for Broadband Internet Access Service* proceeding.<sup>3</sup> The *Public Notice* also set dates for comments and reply comments as July 15 and September 10, 2014, respectively.<sup>4</sup>

Because of high volume with the Commission's Electronic Comment Filing System (ECFS), some parties are experiencing difficulties accessing ECFS. The Commission will treat as timely filed any comments that are filed via [OpenInternet@fcc.gov](mailto:OpenInternet@fcc.gov) or in ECFS by midnight Friday, July 18.
