Dear Ms. Dortch:

On August 27, 2014, Catherine Bohigian, Alex Hoehn-Saric and Larry Christopher of Charter Communications, Inc. (“Charter”); Jeff Eisenach and Greg Kreischer (by telephone) of NERA; and Carrie Apfel and the undersigned of Jenner & Block LLP met with Hillary Burchuk, Bill Dever, Hillary DeNigro (by telephone), Neil Dellar, Marcia Glauberman, Betsy McIntyre and Joel Rabinovitz to discuss the Federal Communication Commission’s (“FCC”) information and data requests in this proceeding.

During the meeting, Charter and its representatives explained Charter’s organization, and the responsibilities of various employees in the company, in order to help identify appropriate custodians for the FCC’s document requests. Charter also described the scope and timing of its responses to the Department of Justice’s information requests and explained how this information could be used efficiently and effectively in responding to the FCC’s requests. In addition, Charter sought clarification and guidance on the scope of the FCC’s questions.

As part of this notice, please find enclosed a copy of Charter’s organizational chart. The organizational chart, which contains proprietary and non-public information, is being submitted on a Highly Confidential basis under the Joint Protective Order in effect in this proceeding.¹ Consistent with the instructions in the Joint Protective Order, the Highly Confidential version of this filing, complete with attachment, has been filed under separate cover, and copies are being
